The appellant filed an RTI application dated 21.4.2012 seeking information with regard to cases where mobile call records are utilized. The appellant sought to know whether the appellant can also obtain mobile call details to defend his case. The CPIO vide reply dated 7.5.2012 held that the RTI Act extends only to seeking information as defined in section 2 (f) and also that information sought appellant was in nature of queries amounting to seeking legal advice. 

These Acts are already available in public domain. In addition, in case there is any such statutory provision in any other law, the same can be complied by the concerned authority.

3. The issue whether the subscriber can obtain his/her own mobile call date records falls in the preview of Department of Telecom. To that extent, the RTI applicant is transferred to DoT u/s 6 (3) of RTI Act, 2005 to provide desired information to the applicant.

It is informed that in case you are not satisfied with the reply, you can prefer an appeal within 30 days from the receipt of this communication to Shri Rakesh Singh, Joint Secretary (Internal Security-I), Room No 197-B, North Block, Ministry of Home Affairs, New Delhi, who is the Appellate Authority in this case.
