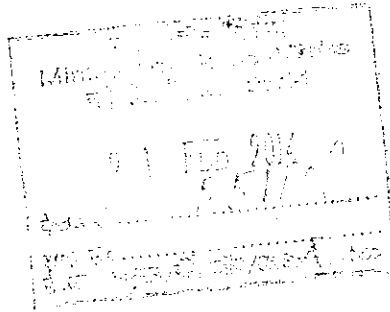



I am to refer to this Ministry's letter of even number dated 20.03.2014 intimating to you that the information sought by you, vide your RTI application dated 04.02.2014, is related with third party for which a communication under Section 11 of the RTI Act, 2005 was sent to them.


2. In continuation, it is informed that the information sought vide Point 1 to 5 of the application, directly/indirectly related to the letter written by CBI to MHA. The said communication from the CBI has been classified/treated as 'Secret' by the CBI (the third party). The third party (CBI), in the matter, has intimated that the Government of India in exercise of powers conferred by sub-section (2) of the Section 24 of the Right to Information Act, 2005 vide Notification No. 442 (E) dated 09.06.2011 has placed Central Bureau of Investigation at Sl.No.23 of Second Schedule to the RTI Act, 2005. In the light of this notification RTI Act, 2005 is not applicable to CBI. Hence, the information sought, vide Point 1 to 5 of your application, is not possible to disclose as exempted under Section 24 of the RTI Act, 2005. Request made under Point 6 of your application under the RTI Act to attest your RTI application is regretted as the same is not covered under the RTI Act, 2005.

3. Under Section 19(1) of the Right to Information Act, 2005, an appeal can be filed within 30 days from the date of receipt of the reply, before the first Appellate Authority, whose particulars are given below :
