(1)	The required information is not maintained by us. J&K Police is under the State Govt. of J&K. You may therefore get the information from the State Govt. directly. However, RTI Act, 2005 is not applicable to J&K.																				
(2)	<p>Insofar as J&amp;K Division (K.II Desk) is concerned, we provide funds to the State Govt. of J&amp;K under Security Related Expenditure (SRE) Scheme. The details of SRE is given below:</p> <p><b>Security Related Expenditure (SRE) Scheme</b></p> <p>In view of the serious militancy/insurgency in J&amp;K, the Govt. of J&amp;K have to incur more expenditure for maintaining peace and tranquility. It has led to an additional burden on its budget. In order to mitigate this problem and with a view to augment the resources of the J&amp;K Government to fight the terrorism and contain militancy besides maintaining law and order in the State, a separate SRE scheme for J&amp;K was introduced. It provides for reimbursement of expenditure on Police (SRE - Police) which mainly support the logistical requirements of police force of J&amp;K and Relief &amp; Rehabilitation (SRE-R&amp;R), which support the expenditure on relief and rehabilitation of the Kashmiri migrants who have been uprooted from the valley during militancy period. 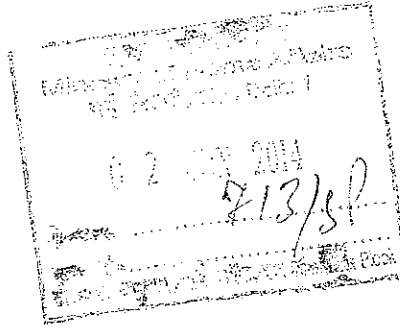
