Whereas Shri Sanjay Bhalla, R/o GI-1055, Sarojini Nagar, New Delhi vide his application dated Nil (received in the Section on 12-05-2014) had sought certain information regarding the pay fixation of Assistants of CSS who were in the pay scale of Rs.6500-10500.

- 2. And whereas the information available in the Ministry of Home Affairs was provided to the applicant vide letter of even number dated 04-06-2014 from the Deputy Secretary (E) and CPIO, MHA.
- 3. And whereas the appellant has filed an Appeal dated 11-06-2014 (received in this Ministry on 18-06-2014) and has referred to the aforesaid reply dated 04-06-2011 and has sought further information for favour of clarity.
- 4. And whereas the appeal has been considered by the undersigned and it is to furnish further information in the matter as under:-

	Information sought by Appellant	Reply
(a)	Two pay fixation orders enclosed with the RTI reply relate to two JHTs only who were in the pay scale of Rs.5500-9000 as on 01-01-2006 and not the Assistants in the pay scale of Rs.6500-10500. Therefore, I prey for providing information pertaining to correct category.	Assistants of CSS were having pre-revised pay scale of Rs.5500-9000 as on 01-01-2006. The pay scale was upgraded to 6500-10500 w.e.f. 15-09-2006. However, till the implementation date of 6 th CPC on 01-09-2008, Assistants continued to draw pay in the pay scale of Rs.6500-10500. After implementation of the 6 th CPC recommendations, Assistants were placed in PB-2 with Grade Pay of Rs.4600/- w.e.f. 01-01-2006. Copies of two pay fixation orders in respect of Assistants are enclosed.
(b)	The post of PS/equivalent were also in the pay scale of Rs.6500-10500 prior to implementation of 6 th CPC, why the reply has been restricted to the post of Assistants only	Ad-II Section deals with posts of Assistants only. For PS/equivalent posts, CPIO concerned has already replied to you vide letter No.A-43020/3/2014-Ad.I(A) dated 04-07-2014.
(c)	As per the Gazette Notification of 6 th CPC, in case of the posts in the pay scale of Rs.6500-10500 as on 01-01-2006, their pay was to be statutorily fixed in PB-2 with Grade Pay of Rs.4800/ Whether it has been done or not, should have been clarified.	

5. The appellant is informed that in view of the position stated in para 4 above, the appeal dated 11-06-2014 is disposed of.

APPEAL AGAINST RTI REPLY

Hon'ble Sir,

Ref: MHA's Letter No. A-42012/49/2014-Ad.II, dated 4th June, 2014 (copy enclosed).

- 2. May I request you to kindly review the whole matter as correct/complete information has not been provided.
- 3. As per Gol, Ministry of Finance, Department of Expenditure, Implementation Cell OM No. F.No. 1/1/2008-IC, dated 13th Nov, 2009 and also OM of even number dated 16th November, 2009, the posts in the pay scale of Rs.6500-10500 have been upgraded to the next higher grade in the pay band PB-2 with grade pay of Rs.4600/- corresponding to the pre-revised scale of Rs.7450-11500. It is also brought out that in case of post already exists in the scale of Rs.7450-11500, the post being upgraded from the scale of Rs.6500-10500 should be merged with the post in the scale of Rs.7450-11500.
- 4. Firstly, two pay fixation orders enclosed relate to two Junior Hindi Translators only who were in the pay scale of Rs.5500-175-9000 as on 1.1.06 and not of the Assistants in the pay scale 6500—10500. The information was sought specifically with regard to the posts in the pay scale of 6500-10500. Therefore, I pray for providing information pertaining to correct category.
- 5. Secondly, it is also to bring out that not only the post of Assistant but also the post of PS/equivalent, to my knowledge, before 1.1.06, prior to the implementation of 6th CPC, were in the pay scale of Rs.6500-10500. Then why the reply has been restricted to the post of Assistant only? I request that the ambit of reply should also include the post of PS/equivalent. It should also have been clarified how upgrading, i.e. from 6500-10500 to 7450-11500 in the pre-revised scale, as brought out in para-3 supra, has been implemented in case of PS/equivalent and Assistants/PAs who were drawing pay in the pay scale of Rs.6500-10500 as on 1.1.06?
- 6. As per the Gazette Notification of 6^{TH} CPC, in case of the the posts in the pay scale of 6500-10500/- as on 1.1.06, their pay was to be statutorily fixed in PB-2 Rs.9300-34800 with Grade Pay Rs.4800/-. Whether it has been done or not, should have been clarified.
- 7. In light of the foregoing rule position, may I request that a revised and correct reply may kindly be provided to me at the earliest, please. The cost of photocopies, if any will be deposited immediately on intimation.
