

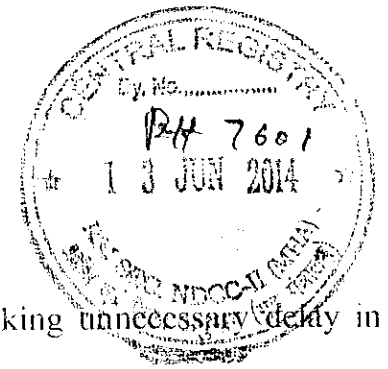

That being an old and debilitating widow and unable to move I had requested my brother in relation to represent my view before the appellate authority and thereby he was told that the requisite file was never given to them by FFR division Ministry of Home Affairs, NDEC -II building Jai Singh Road Parliament Street, Near Jantar Mantar, New Delhi - 110001, and hence. They couldn't trace the requisite papers.

That ever since I filed R11, I had supplied the copy of the order of (under secretary to the government of India ministry of rehabilitation, being the copying of front page of order number 5(82)rest/57/3029 dated 7/11/1957 from the file in fact I have a Front Page copy of this order with me which is attached herewith. It appears the remaining papers were handed over by my late husband to some lawyers. You are requested to direct concerned authorities to provide complete order and complete file to me from their record and oblige me.
  6. That being an old and debilitating women, I am tired of going from one post to another and nobody seems to take pity on me. Now the 1<sup>st</sup> appellate authority has again advised me to go to the predecessor authority (CPIO) or else file 2<sup>nd</sup> appeal with CIC hence this 2<sup>nd</sup> appeal because the two offices are directing me towards each other and not supplying the requisite document to me.
