

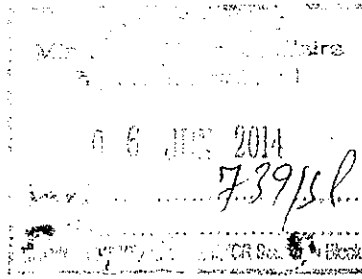


Sub: - Requisition for information as per Right to Information Act 2005 of different Naxals attacks in Indian states

1. How many officers and other ranked security personnels have been killed by Naxalites in Naxals affected states in last 30 years? Please provide state wise and year wise data.
 2. On April 6 2010, Naxalite killed 76 security personnels in Chhattisgarh, Dantewada district. Please provide the name, and address with Phone no. of dependents of martyred security personnel.
 3. In last 30 years how many Civilians have been killed by Naxalites in Naxals affected states? Please provide year wise detail with its affected territory.
