
Sir,

(A) Secretarial Assistance

The above facility will be admissible to him for the first five years after demitting the office as Prime Minister. Office expenses during the first five years shall be admissible to him as per actual. After expiry of five years, he will be entitled to the following facilities:-

- (i) One Personal Assistant in the Pay Band – 2 with Grade Pay of Rs. 4600/-
- (ii) One Peon in the Pay Band -1 with Grade Pay of Rs. 1800/-
- (iii) Office Expenses @ Rs. 6000/- per annum

(B) Travel entitlement

Six return journeys by air by executive class along with companion and free travel by train with companion by the highest class without any restriction on the number of


journeys. These journeys would be over and above any other facility available to him in his capacity as a Member of Parliament or in any other capacity.

(C) Telephone facility entitlement

Telephone facilities as admissible to a Member of Parliament.

2. The expenditure on providing above facilities shall be borne on the budget of the Prime Minister's Office.


