

Please refer to your RTI application Registration No. MHOME/R/2014/61306 dated 30.05.2014 forwarded by Director (LWE-I), MHA vide letter No.II-18015/52/2014-LWE-III dated 19.06.2014 for providing information to you on the said application under Right to Information Act, 2005.

2. The information available with the undersigned in respect of related points are as under:-

Point No. 1: Nil.

Point No. 2: Under the Scheme for Special Infrastructure (SIS) for LWE affected States, the fund is released to cater to requirements of policing and security in the LWE affected districts. The works approved under the Scheme are executed by the LWE affected State Governments. After its implementation during XI Plan period, the Scheme was approved on 02.04.2013 for continuation during the XII Plan period with an added objective of funding pertaining to the upgradation and filling critical gaps for Special Forces of LWE affected States. The funding pattern has been changed from 100% funding by the Central Government to 75% (Central Government share):25% (State Government share) pattern. Since its inception, the year-wise funds released under this Scheme are as under:
