2. Information pertaining to the Left Wing Extremism Operations-II (LWEO-II) Section of LWE Division of this Ministry, with regard to the money spent for controlling naxal activity, as a police response, in respect of the Andhra Pradesh and Jharkhand is given below:


A scheme namely, 'Construction/Strengthening of Fortified Police Stations' is under implementation in Left Wing Extremist (LWE) affected States, under which 400 Police Stations/Outposts have been sanctioned in the 10 LWE affected States @ 2.00 crore per police station on 80:20 (Centre share: State share) basis. Since the inception of the scheme, details of the funds released by this Ministry to Andhra Pradesh and Jharkhand under the said scheme are given below:
