
Subject : Seeking information under RTI Act, 2005 – regarding.



2. As regards expenditure incurred on swearing in ceremony including expenditure on security arrangements is concerned, this unit has no information to furnish and the same may be treated as 'Nil'. It is however noted that a copy of your RTI application has already been forwarded to CS Division and DP-II Division, MHA for furnishing information, if any, that may be available with them. Further, some information on the subject may be available with Cabinet Secretariat, Ministry of Urban Development, Ministry of Defence, Delhi Police, P-II Division, and Public Section of MHA. Accordingly, a copy of your application is being forwarded under Section 6(3) of RTI Act-2005 to CPIOs, Cabinet Sectt., Ministry of Urban Development, Ministry of Defence, Delhi Police, P-II Division, and Public Section of MHA for furnishing requisite information, if any available with them, directly to you.

3. As regards expenditure incurred on security forces, it is stated that different security agencies whose personnel are deployed for security meet their expenditure out of allocations under different budget heads. There is no mechanism to differentiate expenditure on providing security. In view of the above, as also in view of the fact that different agencies, including State Government agencies, are involved, it is difficult to calculate the expenditure on security. In any case, such details are not maintained or available in this Unit.
