Sadiq Masih, Mrs. Rehana Bibi W/o Raja Masih, Sagar Raja S/o Raja Masih, Naveen Raja Masih S/o Raja Masih and Ms. Mary Saba D/o Raja Masih presently R/o 18/340,D.D.A. Flats, Dakshinpuri, New Delhi – 110062, are over staying in India. Unsocial anti National attitude, stay hazardous to Nation. Request for repatriation to Pakistan.

(b) Information requested: FIR is filed against all these Pakistani nationals dated 8/11/2013 with FIR no 0548 ordered by MHA/GOI and complainant was ACP K. Dupty Commissioner of Police (S/O), and SPL. Branch Delhi, for illegally overstaying in India at 18/340, D.D.A. Flats, Dakshinpuri, and New Delhi – 110062 with expired visas. The Ministry issued exit orders to these Pakistani nationals many times on their visas were expired. They came in india on a 45 days visa in December 2000 but without any fear they keep on overstaying here in india with expired visas despite the exit orders being issued by the Ministry to them.

Now all these Pakistani nationals are out on bail, and with a great courage they made their voter ID cards in India and also voted during elections. This is against our constitution and these Pakistani nationals have done. This work

illegally. It's been too long but still no proper action has been taken against a c these Pakistani nationals who are still overstaying as they have no visa to sta in india(Because of their overstaying in india with expired visasino visa to stall in India,FIR was filed against all these Pakistani nationals with FIR no. 0548. ordered by MHA/GOI and complainant was ACP K. Dupty Commissioner of Police (S/O), and SPL. Branch Delhi) But no action has been taken till date attathis and these Pakistani nationals are staying in india without any fear and also engaging themselves in wrong activities and all these Pakistani nationals are going against our constitution as they have made voter ID card in India with changed names and they also voted during elections in India. How it can be possible for all these Pakistani nationals to make voter ID cards? They are not the citizens of india, surely they have done this work illegally. This is a big frauand also against our constitution, so all these Pakistani nationals should be repatriated to Pakistan as possible and a proper action should be taken against all these Pakistani nationals because they are crossing the boundaries of our constitution by being staying here with no visa and by also making voter ID cards illegally.

I'm enclosing all the genuine documents with this appeal. It contains all the replies of The RTI Matter, and FIR which was filed against all these Pakistani nationals and the voter ID list in which their changed names are shown. I hope with all this evidence a quick and a proper action will be taken against all these Pakistani nationals.
