

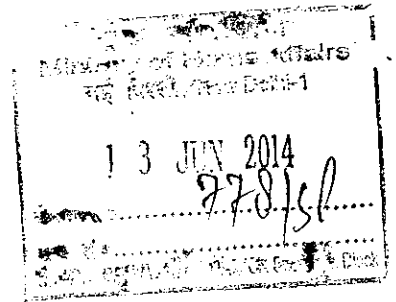


I may kindly be provided the information regarding the following points for which I am herewith an IPO of Rs. 10/- dated 10.6.2014 bearing No. 13 F 859714.

1. The number of personnel working with the Centralized Security Armed Forces separately as on date;
2. The number of personnel working with each Force in Delhi;
3. Whether there is any specific policy regarding posting/transfers of personnel in different Forces;
4. Whether different Forces are governed by different rules in case of posting/transfer;
5. Whether nepotism and favoritism is looked into when a favorite soldier/constable, head constable of an officer is to be retained with the Force deployed in Delhi itself;
6. The specific reasons for not assigning the duties to the soldier/constable, Head constable and other officers who have completed more than 10 or 15 years of the service in Delhi and its sounding areas where there is deployment of Forces;
7. The full details regarding those personnel who have rendered their job in Forces less than 10 years yet over the years, they are happily posted or deployed in Delhi by obtaining the grace of high officers of the Forces;
8. Whether a gross violation of rules and regulations framed in connection with postings and transfers is made openly by the officers for keeping their favorites in Delhi;
9. The time span prescribed by Government for sending personnel on posting especial in Border Security Force;
10. Whether any special ground in case of adverse familial circumstances/serious diseases of parents, kids and wives is taken into account at the time of posting of personnel;

11. If so, the name of personnel alongwith their ranks and time span of their service;
12. Whether the Government intends to have leniency and soft corner towards those personnel in all Forces especially in BSF whose family members are suffering from some problem/diseases due to their absence in their families on account of being perpetually far away from Delhi for more than 15 years;
13. If so, the adopted parameters in this regard;
14. Whether the Government is going to consider the move with regard to scrape the arbitrary powers of officers which very often lead the personnel to the darker side of life when generally mishappenings take place and no body is held responsible for them; and
15. The out sketch of the same?
