Section 10 of GTA MOA- There shall be a GTA Sabha for the GTA. There shall be a Chairman and Deputy Chairman to conduct the business of Council. The GTA Sabha shall consist of forty five elected members and five members to be nominated by the Governor to give representation to members of SC, ST, women and minority communities. The M.Ps. M.L.As, and Chairpersons of municipality(s) of the region shall be Ex-officio Members to this

GTA Sabha. The term of the GTA shall be five years. Section 11 of GTA MOA The Executive Body shall consist of a Chief Executive who will nominate fourteen members out of the elected / nominated members as Executive Member. One of them shall be the Deputy Chief to be nominated by the Chief Executive.

The Chief Executives function has been defined under the sub section (6) of section 32 in the Gorkhaland Territorial Administration Act 2011.
