2. In this regard, it is stated that security to an individual is provided on the basis of threat assessment carried out by the security agencies. Further details in this regard are exempted under Sections 24(1), 8(1)(g) and 8(1)(j) of the RTI Act-2005. Hence, inspection of related files pertaining to security arrangements for any protectee cannot be permitted.

3. As regards application for security, it is stated that security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Hence, an individual apprehending threat to his life and wishing to be provided security may approach the State Government concerned/Police authorities through an application stating his/her grounds for provision of security.

4. An appeal if any, against this reply may be made within 30 days to Shri Sailesh, Joint Secretary (PP & VS) & Appellate Authority, Ministry of Home Affairs, 3rd Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.
