### ORDER

WHEREAS Shri S.K. Mishra, Assitant (retd.), MHA was arrested by the Delhi Police on 02.11.2001 under section 498A/406/34IPC on the basis of a complaint made by his daughter in law.

- 2. AND WHEREAS he was placed under deemed suspension w.e.f. the date of detention i.e. 02.11.2001 vide order dated 29.11.2001.
- 3. AND WHEREAS subsistence allowance was granted to him during the period of his suspension.
- 4. AND WHEREAS his suspension was revoked vide order dated 4.10.2004 on the basis of recommendation of Review Committee without prejudice to the court case pending against him.
- 5. AND WHEREAS Shri S.K. Mishra, retired on superannuation on 3'1.03:2006 and was granted provisional pension as the final outcome of the criminal proceedings against him was pending.
- 4 AND WHEREAS the court has quashed the FIR registered against Shri Mishra.

NOW THEREFORE the Competent Authority has decided that—the period between the date of suspension and the date of revocation be regularized and shall be treated as duty for all purposes.

It has reference to this Ministry's Communication No. A-43020/07/2013-Ad.I(Pt-I) dated 18<sup>th</sup> November 2013 in response to your RTI application dated 27.09.2013 (received in this Ministry on 30.09.2013).

- 2. It is informed that your representation dated 28.06.2013 was examined in the Ad.I Section of this Ministry and the opinion of Department of Personnel & Training was sought, as the validity of recommendations of DPC dated <u>25.03.2004</u> kept in sealed cover for promotion to the Grade of Section Officers on Adhoc basis had expired by the time you were exonerated from the charges by Vigilance Branch/MHA vide Order No. C-12020/135/2001-VC dated 02.02.2011.
- Department of Personnel & Training vide their OM dated 6th February 2014 has opined that MHA should go by the procedure of sealed cover and other DPC guidelines issued by it. As per Para 5 of DoP&T O.M. dated 14.09.1992, the cases where disciplinary case/Criminal prosecution is not concluded even after the expiry of 2 years from the Date of convening of first DPC for promotion, the appointing authority may review the case. In the said case the first DPC was held on 25.03.2004 and two years period completes on 25.03.2006. However you retired from Govt. Service in normal course on 31.03.2006 (within 01 week after completion of said 02 years), there was no time-scope to review the case.
