1.	<p>The use/display/hoisting of the Indian National Flag is regulated by the Prevention of Insults to National Honour Act, 1971 and Flag Code of India, 2002. Part I of the Flag Code contains general description of the National Flag. The detailed provisions regarding hoisting/display/use of the National Flag by members of public, private organizations, educational institutions etc. are given in the Part-II of the Flag Code of India. Part-III of the Flag Code of India relates to display/hoisting of the National Flag by the Central and State governments and their organisations and agencies. The said Act and Flag Code are available on this Ministry's website www.mha.nic.in.</p> <p>The use of the State Emblem of India is regulated by the State Emblem of India (Prohibition of Improper Use) Act, 2005 and the State Emblem of India (Regulation of Use) Rules, 2007 [read with the State Emblem of India (Regulation of Use) Rules, 2010], which are available on this Ministry's website www.mha.nic.in. Its use for various purposes is restricted to the provisions contained in the State Emblem of India (Regulation of Use) Rules, 2007. The use of the State Emblem of India unauthorisedly is an offence in terms of Section 3 [read with Section 7] of the said Act.</p> <p>The use of name or pictorial representation of Mahatma Gandhi is regulated by the Emblems & Names (Prevention of Improper Use) Act, 1950, which is administered by the Ministry of Consumer Affairs, Food & Public Distribution, Deptt. of Consumer Affairs. Accordingly, a copy of your application is being transferred to that Ministry under Section 6(3) of the RTI Act, 2005 for providing the necessary information sought regarding photos of Mahatma Gandhi.</p>

2.	No information is available with the undersigned regarding information sought in this point. A copy of your application is being transferred to the Govt. of Kerala under Section 6(3) of the RTI Act, 2005 for providing the necessary information sought in this point.
3.	The undersigned is not concerned with the information sought in this point.
