
Sir,

Please refer to your reminder dated 31.05.2014 (received through the RTI Section of this Ministry on 04/07/2014) regarding disposal of your RTI application dated 16/12/2013 addressed to the Prime Minister's Office, asking for action taken on your letter dated 30.11.2013 addressed to Hon'ble Prime Minister of India regarding conferment of Bharat Ratna award to Shri Sachin Tendulkar.

2. In this matter, it is informed that neither your above stated letter dated 30.11.2013 addressed to the Prime Minister nor your RTI application dated 16.12.2013, was received in this Section. It has been received only now along with your letter dated 31.05.2014. So far as your request to prohibit Shri Sachin Tendulkar from promoting commercial brand is concerned, there is nothing in the regulations governing Bharat Ratna awards which prohibits a recipient of the Bharat Ratna award from promoting commercial brands.

3. Appeal may be made under Section 19(1) of the Right To Information Act to the Appellate Authority within 30 days. 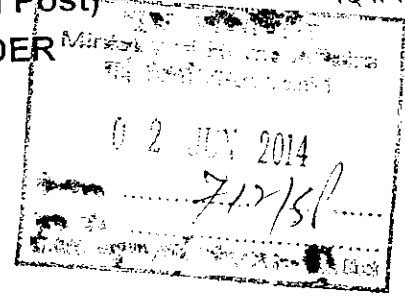

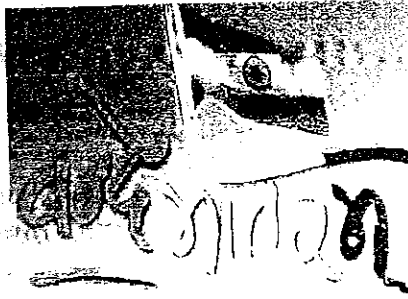
