Please refer to your online RTI applications Registration Nos.MHOMER/2013/60029 dated 02.01.2014 and MHOMER/2013/60059 dated 05.01.2014.

2. Information with regard to RTI application Registration No.MHOMER/2013/60029 dated 02.01.2014 is as under:

- (i) For Point No.(1), it is stated that security to an individual is provided on the basis of threat assessment carried out by the Security Agencies. The details in this regard including names of protectees are exempted under Sections 8(1)(g) and 24(1) of the RTI Act-2005 and therefore cannot be disclosed.
- (ii) For Point No.(2), it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
- (iii) For Point No.(3), it is stated that security to an individual is provided on the basis of threat assessment carried out by the security agencies. Since the matter is examined in consultation with security agencies, the details in this regard are exempted under Section 8(1)(g) and 24(1) of the RTI Act-2005, hence list of individuals who made request for provision of security, cannot be disclosed.

3. With regard to RTI application Registration No.MHOMER/2013/60059 dated 05.01.2014, it is stated that correspondence regarding provision of security may contain threat perceived to his life by the individual and threat assessment carried out by security agencies. In view of this, inspection of correspondence/letters on the subject are exempted under Section 8(1)(g), 8(1)(j) and 24(1) of the RTI Act-2005.
