Please refer to your online RTI application Registration No.MHOMER/2014/60160 dated 14.01.2014.

2. In this regard, it is stated that categorized security cover including Z category security to an individual is provided on the basis of threat assessment carried out by the security agencies. Further details in this regard including the list of people availing Z category security are exempted under Sections 8(1)(g), 8(1)(j) and 24(1) of the RTI Act-2005. Regarding expenditure incurred in providing security, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
