2. यह कि जम्मू-कश्मीर राज्य में रहने वाले उन सभी वीवीआईपी तथा वीआईपी लोगों, जिन्हें सरकार द्वारा सुरक्षा प्रदान की जा रही है, सुरक्षा की श्रेणियों सहित सूची मुहैया कराई जाये तथा यह भी बताया जाये कि उक्त वीवीआईपी लोगों में से प्रत्येक की सुरक्षा पर प्रतिमाह/प्रतिवर्ष कितना खर्च किया जाता है ।
3. यह कि जम्मू-कश्मीर प्रदेश में सेना की संख्या में कमी करने सम्बन्धी क्या कोई विचार लम्बित है, यदि हां तो कारण सहित ब्यौरा दिया जाये

Please refer to your RTI applications dated Nil received in this Unit on transfer on 06.02.2014.

2. In this regard, it is stated that only point No.(2) of your application is related to this unit. Provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Security to an individual is provided on the basis of assessment of threat carried out by the security agencies. Further details in this regard including list of categorized protectee are exempted under Sections 24(1), 8(1)(g) and 8(1)(j) of the RTI Act-2005 and cannot be disclosed. Regarding expenditure incurred on providing security, it is stated that due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.

3. Information on point No.(1) of your application may be related to P-II Division and BM Division of MHA. Accordingly a copy of your application is being transferred to them under Section 6(3) of the RTI Act-2005.


