Please refer to your First Appeal send under Registration No.MHOME/A/2014/60023 (online) dated 16.01.2014.

- 2. Grounds cited by you in your First Appeal have been examined. You have indicated that incomplete or misleading information has been provided. In this regard, it reiterated that security to an individual is provided on the basis of threat assessment carried out by the security agencies. Since the security agencies are exempted under Sections 24(1) of the RTI Act-2005, further details in this regard including inputs from security agencies cannot be disclosed. Details of security cover and security personnel deployed with the protectee are also exempted under Sections 8(1)(g) and 8(1)(j) of the RTI Act-2005 and cannot be disclosed.
- 3. Your First Appeal is disposed of accordingly.
- 4. This issues with the approval of Joint Secretary (PP & VS) and Appellate Authority.
