

Please refer to your online RTI application Registration No.MHOME/R/2014/60290 dated 28.01.2014.

2. In this regard, it is stated that the provision of security to an individual is primarily the responsibility of the State Government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including State Government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office. It is further stated that security to an individual is provided on the basis of threat assessment carried out by the security agencies and hence details of security personnel deployed in the security of Chief Minister, Gujarat cannot be disclosed as the same is exempted under Sections 24(1) and 8(1)(g) of the RTI Act-2005.
