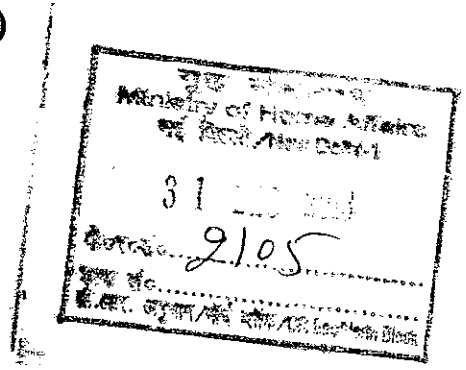




Please refer to your RTI application dated 26.12.2013 received in this Unit on transfer on 16.01.2014.

2. In this regard, it is stated that the security to an individual is provided on the basis of threat assessment carried out by the security agencies. Further details in this regard including names of the categorized protectee are exempted under Sections 8(1)(g) and 8(1)(j) of the RTI Act-2005 and therefore cannot be disclosed.

3. Regarding expending incurred in providing security, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
