Please refer to your RTI application No.RTI/MHA/VIPSEC/1416-2013 dated 31.12.2013 received in this Unit on transfer on 24.01.2014.

- 2. With regard to point Nos. (i) (ii) and (vi) of your application, it may be stated that the responsibility for providing security to an individual is primarily that of the State Government concerned in whose jurisdiction such individual is ordinarily resident or happens to be. Such security is similarly provided on the basis of threat assessment by the security agencies concerned. Security provided by the Central Government is on the basis of threat assessment carried out by the Central Security Agencies and it is subject to review by High Level Group/Committee having representatives of MHA and security agencies concerned. The recommendations of such High-level group/committee are submitted to the competent authority for consideration. There is no committee that 'decides' allocation of security to individuals. State Governments have their own similar mechanism for assessment of threat and provision of security.
- 3. With regard to point Nos. (iii) and (iv) of your application, it is stated that the information sought is exempt under Sections 8(1)(g), 8(1)(j) and 24(1) of the RTI Act-2005.
- 4. With regards to point No.(v) of your application, it is stated that the information sought pertain to the Home Department, Government of NCT of Delhi to whom a copy of your application is being forwarded for providing information directly to you.
- 5. With regard to point No.(vii) of your application, it is stated that the information sought pertains to Delhi Police to whom a copy of your application is being forwarded for furnishing the information directly to you.
