2. यह कि सुरक्षा व्यवस्था किस श्रेणी की है और प्रत्येक व्यक्ति की सुरक्षा में कितने-कितने गार्ड तैनात हैं ।
3. यह कि उक्त सुरक्षा पर कितनी राशि प्रतिमाह/प्रति वर्ष सरकार द्वारा अथवा उक्त व्यक्ति द्वारा वहन की जाती है, ब्यौरा दें ।

Sir,

Please refer to your RTI applications dated Nil received in this Unit on transfer on 16.01.2014 regarding provision of security to Central Ministers, MLAs etc.

2. In this regard, it is stated that security to an individual is provided at government cost on the basis of threat assessment carried out by the Security Agencies. Further details in this regard are exempted under Sections 8(1)(g), 8(1)(j) and 24(1) of the RTI Act-2005. Regarding expenditure incurred in providing security, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.

3. However, a copy of your application is being forwarded to Delhi Police for providing requisite information pertaining to them, directly to you.

4. An appeal if any, against this reply may be made within 30 days to Shri Lokesh Jha, Joint Secretary (PP & VS) & Appellate Authority, Ministry of Home Affairs, 3rd Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.
