- As per section 7(8) of the RTI Act 2005, In case of rejection of my application. I kindly request you to provide the reason for such rejection and not just quote a section of RTI. Also, I request you to provide the details of Appellate authority.
- As per section 8 (1) (j) of the RTI Act 2005, the information which cannot be rich ed to the Parliament or a State Legislature, shall not be denied to any person.
- As per section 8(2) of the RTI Act 2005, Notwithstanding anything in the Official Secrets Act, 1923 nor any of the exemptions permissible in accordance with subsection (1), a public authority may allow access to information, if public interest in disclosure outweighs the harm to the protected interests.
- As per section 7(2) of the RTI Act 2005, in case of no decision received within 30 days, the PIO shall be deemed to have refused the request.
- As per section 6(2) of the RTI Act 2005, An applicant making request for information shall not be required to give any reason for requesting the information or any other personal details except those that may be necessary for contacting him.
- As per section 7(6) of the RTI Act 2005, Notwithstanding anything contained in subsection (5), the person making request for the information shall be provided the information free of charge where a public authority fails to comply with the time limit specified in sub-section (1).
- As per section 19(5) of the RTI Act 2005, In any appeal proceedings, the onus to prove that a denial of a request was justified shall be on the Central Public

Sir. Please refer to your RTI application dated 03.01.2014 received in this unit on transfer on 13.02.2014.

- In this regard, it is stated that the provision of security to an individual is primarily the responsibility of the State Government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Further, security is provided on the basis of threat assessment carried out by the security agencies. Further details in this regard is exempted under Sections 24(1), 8(1)(g) and 8(1)(i) of the RTI Act-2005 and therefore cannot be provided to you. Regarding expenditure incurred on providing security, it may be stated that due to the involvement of multiple agencies, including State Government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
