- 2. In this regard, it is stated that the responsibility for provision of security to an individual is primarily that of the State Government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. The security is provided on the basis of threat assessment carried out by the security agencies. Hence details of the protectees in different States may be obtained from the State Government/Union Territory concerned under the provisions of the RTI Act-2005.
- 3. So far as the protectees in the Central list are concerned, it may be stated that the number of categorized protectees varies from time to time based on the reviews carried out taking into account the threat assessment made by the security agencies. Based on the reviews carried out in consultation with security agencies, security is continued, upgraded, downgraded or withdrawn. However, as on date, details sought by you with regard to number of protectees in different categories is as under:

Z category - 63 protectees
Y category - 104 protectees
X category - 31 protectees

4. In addition, some protectees are provided security by Delhi Police on positional basis taking into account the threat attached to the position held by them under the Government. Information in this regard maybe available with Delhi Police. Accordingly, a copy of your RTI application is being transferred to Delhi Police under Section 6(3) of the RTI Act-2005 for providing requisite information directly to you.

- 5. Since security cover to an individual is provided on the basis of threat assessment carried out and inputs given by security agencies, further details in this regard including list of protectees are exempted under Section 24(1), 8(1)(g) and 8(1)(j) of the RTI Act-2005 and cannot be disclosed
