Please refer to your online RTI application Registration No.MHOME/R/2014/80114 dated 07.02.2014.

2. In this regard, it may be stated that the responsibility for providing security to an individual rests primarily with the State Government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Such security to an individual is provided on the basis of assessment of threat carried out by the security agencies. Further details in this regard are exempted under the provision of Sections 24(1), 8(1)(g) and 8(1)(j) of the RTI Act-2005. Immediate family members of the Prime Ministers or former Prime Minister are also provided security as per provisions of the SPG Act.

3. As regards expenditure on providing security, it may be stated that due to involvement of multiple agencies, including State Government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.

4. Some information on the subject may be available with the Cabinet Secretariat. Accordingly, a copy of your application is being forwarded to the Cabinet Secretariat for furnishing any information that they may have, directly to you.

5. An appeal if any, against this reply may be made within 30 days to Shri Lokesh Jha, Joint Secretary (PP & VS) & Appellate Authority, Ministry of Home Affairs, 3rd Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.
