Please refer to your online RTI application Registration No.MOCAV/R/2013/60325 dated 14.12.2013 received in this unit on transfer on 05.02.2014.

2. In this regard, it is stated that the matter of exemption from pre-embarkation security checks at airports pertains to the Ministry of Civil Aviation. However, exemption in case of Shri Robert Vadra was recommended to Ministry of Civil Aviation on security considerations in consultation with the Central Security Agencies. Shri Robert Vadra is exempted from pre-embarkation security checks at Indian airports only when he is accompanying SPG protectees. Further details in this regard are exempted under Section 24(1) of the RTI Act-2005.
