Please refer to your online RTI application Registration No.PMOIN/R/2013/60608 dated 16.12.2013 received in this unit on transfer on 13.02.2014 and reply sent to you by Ministry of Civil Aviation vide their letter No.AV.13024/1/2013-AS dated 28.01.2014.

- 2. In regard to paras (1) and (3) of your above-mentioned RTI application, it is stated that the matter of exemption from pre-embarkation security checks at the airport, is under the jurisdiction of Ministry of Civil Aviation. However, in some cases, Ministry of Home Affairs in consultation with the security agencies, has recommended for exemption from pre-embarkation security checks at the airports, on security grounds. Shri Robert Vadra is exempted from pre-embarkation security check at Indian airports only when he accompanies an SPG protectee. Further details in this regard are exempted under Section 24(1) of the RTI Act-2005.
- 3. As regards non-extension of similar facility to Smt. Priyanka Gandhi, it may be stated that as per instruction issued on the subject by the Bureau of Civil Aviation Security, Ministry of Civil Aviation, all SPG protectees(which includes Smt. Priyanka Gandhi Vadra) are exempted from pre-embarkation security checks at Indian airport.
