In this regard, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Security to an individual is provided on the basis of threat assessment carried out by the security agencies. Due to the involvement of multiple agencies, including state government agencies in providing security, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.

3. Details of Expenditure on providing security to President of India may be available with Delhi Police and President Secretariat. Details of expenditure on security to PM may be available with Cabinet Secretariat. Accordingly, a copy of your application is being transferred to Delhi Police, President Secretariat and Cabinet Secretariat under Section 6(3) of the RTI Act-2005 for providing information directly to you.
