Please refer to your RTI application dated 30.01.2014 received in this unit on transfer on 03.03.2014.

2. In this regard, it may be stated that this unit is not aware of any rule or law under which an individual is formally classified as a VIP/VVIP. This unit deals with matters related to personal security which is provided based on assessment of threat perception carried out by security agencies. It is further stated that the term 'VIP/VVIP' are not part of any official classification and is used more in a colloquial sense. Therefore, this unit is also not aware as to which Ministry/Department, if any, deals with the subject/categorization of VIP/VVIP. Hence, the requisite information, in so far as this unit is concerned, may kindly be treated as 'Nil'.

3. However, CS Division, MHA which deals, inter-alia with privileges of the President, Union Ministers, Governors and courtesies to be shown to various dignitaries etc, may have some information on the subject. Accordingly, a copy of your application is being transferred under Section 6(3) of RTI Act-2005 to CPIO, CS Division, MHA to furnish information, if any, available with them. Similarly, a copy of your application is also being transferred to Public Section of the Administration Division of MHA, which deals, inter-alia with the Table of Precedence, for providing information, if any, available with them on the subject.



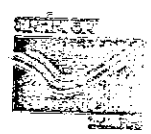
