Please refer to your RTI application dated 27.12.2013 received in this unit on transfer on 03.04.2014.


- 2. In this regard, it is stated that 'Public Order' and 'Police' being State subjects, providing security to religious sites/places within their jurisdiction and enhanced security inside the complex wherever needed is primarily the responsibility of the concerned State Government/Union Territory Administration. Central Armed Police Forces are placed at the disposal of the States/Union Territories for strengthening the security arrangements at religious places to the extent possible, as and when requested by them. It is for the State Governments/UT Administrations to deploy the Para Armed Police Forces for security of religious places taking into account of the threat perception. Expenditure in providing security is borne by the State Government concerned. Further information in this regard may be obtained from the State Government concerned directly under the RTI Act-2005. Central Forces have been deployed for the security of Shri Ram Janam Bhumi Temple in Ayodhya, Krishna Janam Bhoomi Temple in Mathura and Kashi Vishwanath Mandir in Varanasi.
- 3. Details of security personnel deployed for providing security to religious places and their expenditure may be available with State Government concerned. The requisite information in this regard may be obtained from the State Government concerned directly under the RTI Act-2005. However, a copy of your application is being transferred under Section 6(3) of the RTI Act-2005 to P-II Division, MHA for providing information, if any, that they may have on the subject, directly to you.
