Please refer to your RTI application dated 21.04.2014 received in this unit on transfer on 28.04.2014.

2. As regards your request for provision of information treating this case as involving life and liberty of a person, it may be stated that you have sought information in respect of a third person and therefore attracts provisions of Section 8(1)(j) of the RTI Act-2005.
3. As regards points (9) to (15) of the application, it may be stated that law and order being a State subject, the provision of security to an individual is primarily the responsibility of the State Government concerned, under whose jurisdiction an individual is ordinarily resident or happens to be. Security to an individual is provided on the basis of threat assessment carried out by the security agencies, which are exempt from the provision of the RTI Act-2005. In view of this, further details in this regard, being exempt under the provisions of Section 24(1) and 8(1)(g) of the RTI Act-2005, cannot be disclosed.
4. Details with regard to point Nos. (1) to (8) of your application are not available in this unit.
5. As Shri Ashutosh Ji Maharaj is a resident of Punjab, you may like to approach Government of Punjab directly under the RTI Act-2005 for requisite information.


