With regard to Point Nos.(8) and (8.1) of your application, it is stated that normally the security agencies concerned, the Secretariats/office of the President/Vice-President/Prime Minister and the State Government(s)/Local Police are involved in security related duties during movements of the above-named dignitaries. In case of journeys abroad, other agencies including Ministry of External Affairs, the foreign government(s) and foreign security agencies concerned, would also be involved.
