Sir,

Please refer to your RTI application dated 05.07.2014 received in this Unit on transfer on 17.07.2014.

2. In this regard, it is stated that the responsibility for providing security to an individual rests primarily with the State Government concerned in whose jurisdiction such individual is ordinarily resident or happens to be. The Central Government also provide security to some individuals, primarily those who are resident in Delhi. Security is provided based on comprehensive assessment of threat carried out by the Security Agencies. The general categorization of security provided by the Central Government for individual consists of 4 categories, namely, 'X', 'Y', 'Z' and 'Z+'. Certain senior functionaries of the Government, such as Ministers of the Government, Judges of Supreme Court and High Courts etc. are provided security in 'Y'(statutory) category based on threat attached to the post held by them.

3. There are laid-down norms that are followed in the matter of providing security. Further details in this regard, including number of personnel deployed, vehicles provided, guidelines etc. are exempt under Section 8(1)(g), 8(1)(j) and 24(1) of the RTI Act-2005 and cannot be disclosed.

4. The number of protectees is not fixed and varies over time depending upon periodic reviews based on latest inputs of threat. However, the number of threat-based protectees in the Central list on different dates during the period 2010-2014, were as follows:

5. As regards expenditure on security, it may be stated that due to involvement of multiple agencies, including State Government agencies, it is difficult to estimate the expenditure on security. Moreover, such expenditure is incurred by the security agencies concerned under their own budgetary allocation and under different heads of accounts and such figures are neither centrally available nor maintained in this Ministry.

6. A copy of your application is being transferred under Section 6(3) of the RTI Act-2005 to Delhi Police for providing information, if any they have on the subject directly to you.

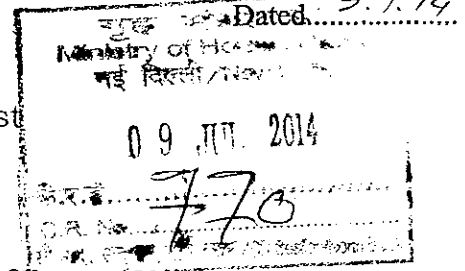
