Sir,

Please refer to your RTI application dated 30.07.2014 received in this unit on transfer on 12.08.2014.

2. In this regard, it is stated that security to an individual is provided on the basis of comprehensive assessment of threat carried out by the security agencies. Further details in this regard including details of security provided and number of security personnel deployed for the purpose are exempted under Section 8(1)(g), 8(1)(j) and 24(1) of the RTI Act-2005 and cannot be disclosed. As regards expenditure on security, it may be stated that due to involvement of multiple agencies, including State Government agencies, it is difficult to estimate the expenditure on security. Moreover, such expenditure is incurred by the security agencies concerned under their own budgetary allocations and under different heads of accounts and such figures are neither centrally available nor maintained in this Ministry.

3. Information sought by you may also be related to SPG. Accordingly a copy of your application is being transferred under Section 6(3) of the RTI Act-2005 to CPIO, SPG for providing requisite information, if any, directly to you.

4. An appeal if any, against this reply may be made within 30 days to Shri Sailesh, Joint Secretary (PP & VS) & Appellate Authority, Ministry of Home Affairs, 3rd Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.

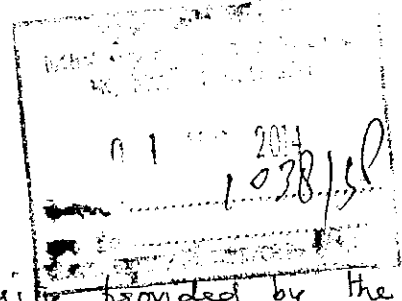
