As regards expenditure on security, it may be stated that due to involvement of multiple agencies, including State Government agencies, it is difficult to estimate the expenditure on security. Moreover, such expenditure is incurred by the security agencies concerned under their own budgetary allocations and under different heads of accounts and such figures are neither centrally available nor maintained in this Ministry.
