Sir,

Please refer to your RTI application dated 27.04.2014 received in this unit on transfer on 09.06.2014.

2. In this regard, it is stated that the subject matter is partly related to this Unit. The subject matter of exemption from pre-embarkation security check at the airports is under the jurisdiction of Ministry of Civil Aviation. However, in some cases, Ministry of Home Affairs in consultation with the Central Security Agencies may recommend exemption for some individual from pre-embarkation security checks at the airports on security grounds. The recommendation in respect of Shri Robert Vadra for exemption from pre-embarkation security checks at the Indian airports, only when he is accompanying an SPG protectee, was made to Ministry of Civil Aviation in consultation with Central Security Agencies. Further details in this regard, including file notings, are exempt under Section 24(1) of the RTI Act-2005 and cannot be disclosed.

3. Information regarding names of other individuals who are exempted from pre-embarkation security checks while accompanying the SPG protectees may be related to Ministry of Civil Aviation as exemption from pre-embarkation security checks is under the jurisdiction of Ministry of Civil Aviation. Accordingly, a copy of your application is also being transferred to CPIO, Ministry of Civil Aviation, under Section 6(3) of the RTI Act-2005 for providing information on the remaining points of your application directly to you.

4. An appeal if any, against this reply may be made within 30 days to Shri Sailesh, Joint Secretary (PP & VS) & Appellate Authority, Ministry of Home Affairs, 3<sup>rd</sup> Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.
