- 2. In this regard, it is stated that the term 'VIP' is not part of any formal official nomenclature and there is no formal procedure whereby an individual is classified as a 'VIP' or non-VIP for the purpose of provision of security cover. Security to an individual is provided on the basis of comprehensive threat assessment carried out by the security agencies. As regards the number of Z plus protectees, it is stated that it is not possible to arrive at the exact number of categorized protectees as the number varies from time to time, depending upon review of the security cover based on the threat assessment made by the Central Security Agencies. However, there are 39 numbers of Protectees in the Z plus category in the Central list as on date. Further details in this regard are exempted under Section 24(1) and 8(1)(g) of the RTI Act-2005 and cannot be disclosed. An individual can approach Police authorities for provision of security, if he or she apprehends threat to his/her life.
- Regarding expenditure incurred on security, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
