- 3. However, information related to expenditure on providing security to the President and Prime Minister may be available with Delhi Police and SPG. Accordingly, a copy of your application is being forwarded Delhi Police and SPG for providing information that may be available with them. You are requested to contact the concerned CPIOs for further information in this regard.


