

2. It may be clarified that since, under the Constitution, Law & Order, is a State subject, the responsibility for providing security to any individual lies primarily with the State Government concerned in whose jurisdiction such individual ordinarily resides or happens to be. Even in the case of individuals given security cover by the Central Government, the various Police and security organization concerned have their own separate budgetary heads. In view of the above and in view of the involvement of multiple agencies, including State Government agencies, in providing security, it is very difficult to estimate the expenditure incurred on the same. In any case, such records of expenditure are not maintained in this unit.

3. You are, therefore, requested to contact the concerned PIO of the State Government, State Police authorities and other authorities concerned, directly to obtain the information you seek.

4. Your First Appeal is disposed of accordingly.

1. That in my RTI Application the reply for the Point no. 3 (Copy of the RTI Attached) the question was that "Please provide the following details that from January 1984 to December 2012 what was the total expenditure done in terms of providing security cover to dignitaries, VIP's, Minister's, Cabinet Minister's, Army Chief's, Prime Minister, President and other Protectee's that may include private citizen under threat as well. Please provide the details under different heads on yearly basis along with the details that what the amount was paid by the state and Center under different heads." to which the reply which I received from Mr. Girish Kumar Director (VS) & CPIO (Copy Attached) is not only incomplete whereas it is completely off track as I asked about the expenditure and since it is not maintained in your office it could have been forwarded to the concerned SPIO for the details and the same could have been provided to me. Si, it is my humble request that you may please intervene and provide me the answer to my question in regards to the Total Expenditure done between 1984 till 2012 on all the protectees all across India or transfer the application to the relevant SPIO to provide me the information on urgent basis.


