Please refer to your Appeal dated 15.03.2013, for providing information with regard to your RTI application dated 24.09.2012 which was received in this unit on transfer on 22.05.2013 for providing information on point No.II of your application.

- 2. In this connection, it is stated that under the constitution of India, Law and order is a state subject and it is primarily the responsibility of the State Governments/UT Administrations to provide security to an individual, who is ordinarily resident in their jurisdiction. Security, if any, is provided only on the basis of comprehensive assessment of threat by security agencies. Details of security provided, including details of deployment of security personnel, etc. are exempt under sections 8 (1) (g) and 24 (1) of the RTI Act, 2005. However, at present, there are 207 number of protected persons in the Central list.
- 3. Details of persons getting security from the State Government/State Police may be obtained from the State Government/State Police authorities concerned. A copy of your RTI application is being forwarded to CPIO, Delhi Police for necessary action under the RTI Act-2005.
- 2. An appeal if any, against this reply may be made within 30 days to Shri Lokesh Jha, Joint Secretary (PP) & Appellate Authority, Ministry of Home Affairs, 3rd Floor, NDCC-II Building, Jai Singh Road, New Delhi-110003.
