Sir,

Please refer to your RTI application dated 17.03.2013 received in this unit on transfer on 22.05.2013 for providing information related to this unit, if any.

2. In this regard, it is stated that the desired information regarding exemption allowed to certain individual's from pre-embarkation security checks is not related to this unit and may be related to Ministry of Civil Aviation. Accordingly, a copy of your application is being transferred to CPIO, Ministry of Civil Aviation for necessary action.

3. As regards facilities available to individuals referred to in point Nos.(6) and (8) of your application, it is stated that the issue of provision of security is partly related to this unit. In this regard, it is stated that under the constitution of India, Law and order is a State subject and it is primarily the responsibility of the State Governments/UT Administrations concerned to provide security to an individual, in whose jurisdiction such an individual is ordinarily resident. Security, if any, is provided only on the basis of comprehensive assessment of threat by security agencies. Details of security provided, including reasons for providing security, names of individuals having security, etc. are exempt under sections 8 (1) (g) and 24 (1) of the RTI Act, 2005. However, at present, there are 207 number of categorized central protectees.

4. As regards other facilities available to persons referred to in points (6) and (8) of your application, some part of it may be related to Ministry of Parliamentary Affairs. Accordingly, a copy of your application is being transferred to CPIO, Ministry of Parliamentary Affairs for necessary action.

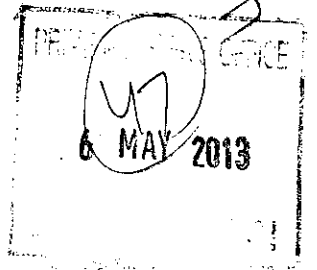
