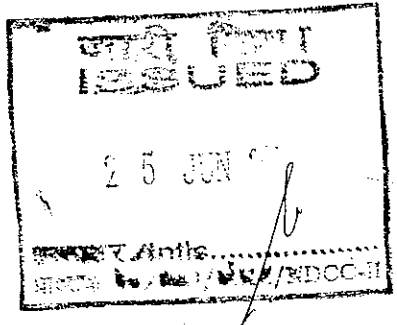

Please refer to your RTI application dated 20.03.2013 received in this unit on transfer on 27.05.2013, regarding setting up of a 'National Media Commission' to provide security to Journalist.

19. 2. In this regard, it is stated that the subject matter of setting up of National Media Commission, does not relate to this unit. As regards provision of security, it may be stated that responsibility for providing security to an individual, including a journalist, lies primarily with the State Government in whose jurisdiction such individual is ordinarily resident. This unit deals with matter related to provision of security cover to an individual on the basis of comprehensive threat assessment made by the Central Security Agencies. This unit is neither aware of nor dealing with setting up of any Commission as mentioned in your application, for providing security to journalists. The requisite information in this regard, in so far as this unit is concerned, may, therefore, kindly be treated as 'Nil'.
