In this regard, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual ordinarily resides or happens to be. Security to an individual is provided on the basis of threat assessment carried out by the Security Agencies. Further details in this regard are exempted under Sections 8(1)(g) and 24(1) of the RTI Act-2005.

3. Due to the involvement of multiple agencies, including state government agencies in providing security, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
