- 2. In this regard, it is stated that based on threat perception as assessed by security agencies, security cover in four categories i.e. X, Y, Z and Z plus is provided to individuals. It is further stated that under the constitution of India, Law and order is a State subject and it is primarily the responsibility of the concerned State Governments/UT Administrations to provide security to an individual, in whose jurisdiction such an individual is ordinarily resident. Details of security provided, including reasons for providing security, names of individuals having security, number of personnel deployed etc. are exempt under Sections 8 (1) (g) and 24 (1) of the RTI Act, 2005. Regarding expenditure incurred in providing security, it is stated that due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.


