2. In this regard, it is stated that security to an individual is provided at Government cost on the basis of comprehensive threat assessment made by the Central Security Agencies. The details in this regard including nature of threat etc. are exempt under Section 8(1)(g), 8(1)(j) and 24(1) of the RTI Act-2005 and therefore cannot be disclosed.

3. With reference to your two RTI applications, dated 29.07.2013, it is stated that the IPOs furnished alongwith RTI applications are wrongly drawn. The IPO should be in favour of "Accounts Officer, MHA, New Delhi". Accordingly, the above two applications cannot be processed and are returned in original.
