**Subject:- First Appeal under the RTI Act-2005-reg.**

Sir,

Please refer to your First Appeal dated 03.08.2013 received in this unit on 14.08.2013.

2. Grounds cited by you for filing first appeal have been examined and it is observed that there is no merit in the points raised in the first appeal. In this regard, it is stated that information sought in terms of point Nos.3,5,6 and 7 of your RTI application dated 08.05.2013 was with regard to threat inputs in respect of the individual. Security is provided based on the threat inputs received from the Security Agencies. It is clearly laid down in the RTI Act-2005 that nothing contained in the Act shall apply to the intelligence and security organizations specified in the Second Schedule, being organizations established by the Central Government or any information furnished by such organizations to the Government. Hence the details sought by you are exempt under Section 24(1) of the RTI Act. Information sought is also exempt under Section 8(1)(g) which states that information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes, is exempted.


3. As regards point No.(8) regarding Supreme Court direction on providing security, it may be stated that the matter is still under adjudication of Hon'ble Supreme Court.

5. Your First Appeal is disposed of accordingly.
