- 2. As per the relevant AVSEC order issued by the Ministry of Civil Aviation, Bureau of Civil Aviation Security, Shri Robert Vadra is exempted from pre-embarkation security checks at all Indian airports only when he is accompanying SPG protectees.
- 3. As regards the grounds for such exemption, it may be stated that such exemption has been made on security grounds in consultation with Central Security Agencies. Details in this regard are exempt under Section 24(1) of the RTI Act-2005.
